

BSF LIMITED LIABILITY WARRANTY

Brand Standard Furnishings, LLC warrants our products to be free of manufacturing defects in materials, finishing and workmanship under normal use in a commercial setting for a period of two (2) years from the date of the original invoice. This warranty does not apply to any item that is damaged due to misuse, negligence, improper cleaning or stain prevention materials, beverages, humidity, alteration, abuse, accident or abnormal use. Products sold by Brand Standard Furnishings LLC that are not included in our original invoice are not covered under our warranty. Any modification to product included in this invoice is considered custom and excluded from warranty. We do not warrant product designs submitted from third parties and are not responsible for any defects resulting from such design. During the two years of this period, we will repair free of charge, any product covered under warranty that has failed due to a manufacturing defect. Normal softening and flattening of foam and fibers is not considered a defect. The item must remain upholstered in its original fabric to be covered by this warranty. This warranty only covers workmanship and labor; it does not apply to any COM/COL fabrics or other materials provided by the customer or any other vendors regardless of how Brand Standard Furnishings manufactured or otherwise used those fabrics and/or materials in the manufacture of the purchased product(s).

To obtain service under this warranty, defects must be reported to Brand Standard Furnishings within the warranty period in writing accompanied with a copy of the original purchase order and invoice.

This warranty is your sole remedy. Brand Standard Furnishings, LLC expressly excludes any warranty of merchantability of fitness for a particular purpose as to any products, or for infringement upon any copyright, patent or intellectual property. Brand Standard Furnishings, LLC will not be responsible for damages in excess of the price paid for the product in question and will not, under any circumstance, be responsible for incidental or consequential damages, even if it had reason to know of the possibility of such damages. In no event shall Brand Standard Furnishings be liable or responsible for any lost profits or for any amounts other than the repair or replacement of the products covered herein, with the determination of whether repair or replacement is the proper remedy to be based on the terms of this Warranty and Brand Standard Furnishing's sole discretion. Intheeventofan expectable claim, the client must cover the cost of shipping, Brand Standard Furnishings is not responsible or liable for the cost of disposal or removal of the purchased product(s), and in no event is Brand Standard Furnishings responsible or liable for any special damages, consequential damages, and/or non-pecuniary damages.

This Warranty gives you specific legal rights, and you may have other rights that vary from state to state. Some states do not allow the exclusion of implied warranties or the limitation of damages, so the above exclusions and limitations may not apply to you. In the event the warranty exclusions do not apply to you, then, where legally permissible, such implied warranties are limited in duration to the stated warranty period and no warranties apply after that period. In circumstances in which the warranty provided herein does not apply, the



products involved are, where legally permissible, still subject to the above disclaimer of implied warranties and the above limitation of damages. This warranty applies to the original purchaser of the product.

This warranty is void and unenforceable, and Brand Standard Furnishing is not responsible or liable for any costs, damages, or expenses, if a claim is not made and adequately documented within 48 hours of discovery of the claim. For a claim under this warranty, any Refusal of Delivery must be reported and documented within 48 hours of final delivery. If any damages occur during shipment, this warranty is void and unenforceable if such damages are not documented and reported within 48 hours of receipt of the purchased products. Additionally, any such damages must be included as written exceptions on the Proof of Delivery. This warranty is void and unenforceable as to any damage that occurred in conjunction with the shipment of purchased product(s) if the products are claimed at Brand Standard Furnishing's location and delivered by a third party carrier.

For purposes of this warranty, FOB Location is designated on PO and shipping is coordinated with a 3rd party shipping provider.
